**Transient:** A transient student is a student who has attended another college or university during the last 12 months and who wants to attend Miami for one semester as a non-degree student. Transient students may not attend Miami for two consecutive terms (fall, spring, summer) unless they are attending the Luxembourg campus exclusively.

**Note:** If you wish to attend Miami as a transient student, you must submit this application, an application fee of \$50 and an **official transcript** sent directly to Miami University from the last college you attended. You must be in good academic standing at your current institution with at least a 2.0 grade point average to be admitted.

**Fee:** You must submit an application fee of \$50 (made payable to Miami University) with this application. A new application fee is required for each semester you apply as a transient student.

**Deadline:** You must submit a **complete** application and credentials no later than **one week** prior to the first day of classes.

I accept the responsibility to become familiar with such regulations, and acknowledge that I may be held accountable for conduct in violation thereof even in the absence of such familiarity."
